**INDEX ANNOUNCEMENT**

**Treatment of Amcor Limited Demerger within the S&P/ASX 200 Index**

**Sydney, December 10, 2013:** S&P Dow Jones Indices announced today that it will make the following changes in the S&P/ASX 200 Index subject to regulatory approval of the proposed scheme of arrangement whereby Amcor Limited (ASX: AMC) will spin-off Orora Limited (ASX: ORA).

Amcor Limited will spin-off 1 share of Orora Limited for every 1 Amcor Limited share held. Orora Limited will be added to the S&P/ASX 200 Index after the close of trading on December 17, 2013 at a zero price.

Due to the close proximity of this event to the December quarterly review, Perseus Mining Limited (ASX: PRU) will be removed from the S&P/ASX 200 Index as a result of the inclusion of Orora Limited after the close of trading on December 20, 2013.
